

Census of Public & Semi - Government Sector Employment 2006

Department of Census and Statistics

Introduction

Department of Census and Statistics conducts the Census of Public and Semi-Government sector Employment once in four years since 1980.This is the 7th in the series which was conducted on 1st July 2006. It is designed to publish the data by ministry in series of a bulletins. As such this bulletin contains the 'finalized data' pertaining to 'Ministry of Finance and Planning' Ministry of Finance and Planning consists of 18 institutions in State Sector and 23 Institutions in Semi-Government Sector.In this bulletin, only State Sector institutions are included.

Table 1 shows that estimated number of total employees in the state sector in the Ministry of Finance & Planning is 7500 of which 6473 employees were enumerated. It can be seen that all the institutions under the ministry have more than 83% coverage except the Department of Customs which had the lowest coverage of 61.3%

'Technicians and Associate Professionals' group has the highest number of employees where the majority of them is consisted of Statistical Officers, Tax Officers and Assistant Superintendents of Customs. In all these categories, percentage of males is higher than the females except the 'Clerks and Related Workers' group. 'Craft and Related Workers' group is consisted of the least number of employees.




Figure 2 : Percentage Distribution of Employees (Enumerated) by Major Occupational Group and Sex




Figure 3 : Distribution of employees (Enumerated) by Status of Appointment and Sex






Figure 1 : Distribution of Employees (Enumerated) by Age and Sex

Out of the total enumerated employees, highest number of employees are in the secondary level followed by Tertiary & Senior Level and Primary Levels respectively.

Department of Inland Revenue has more Tertiary & Senior Level employees than Secondary and Primary Level employees since most employees in Inland Revenue Service belong to Tertiary & Senior Level Category.



Figure 6 : Distribution of Employees (Enumerated) by Computer Literacy and Sex




Figure 7 : Distribution of Employees (Enumerated) by language Abilities




Figure 5 : Distribution of Employees (Enumerated) by Salary Group and Sex
