A copy of the death certificate is sent to the Divisional Secretariat Office along with the monthly return of deaths which includes the details of deaths occurred in a particular month.	

The Additional District Registrars receive the returns from all Divisional Secretariate offices attached to them. The Additional District Registrars send these returns to the Statistical Division of the Registrar General's Office for data processing purposes.

2. Do a visual check for completeness
3. Coding of data
4. Entry of data
5. Run edit program for each District batch
6. Produce error report
7. Correction of errors on the report
8. Change incorrect data using the corrected error report
9. Re-run the edit program and repeat the error correction procedure
10. Produce final tables on clean data with a backup of clean data.
