

P R E F A C E

This is the twelfth report published on the Annual Employment Survey since 1971. Establishments in the private sector (organised sector) and those in the public sector which engaged only in productive and distributive business and commercial activities were canvassed by this survey. The estate sector encompassed tea estates over 25 acres and rubber and coconut estates of 50 acres and above. Data relating to the survey were collected through the post followed-up by reminders and personal visits by the field staff.

It has been observed that the rate of Non-response has been increasing very rapidly from one year to the next. It was 28.4 % in 1982 whilst in 1983 it has risen to 31 %. Although many steps had been taken to remedy the situation by covering more establishments so far it has not met with any great success. The coverage situation deteriorated further in 1983 due to the ethnic disturbances which occurred in July 1983, where many records of business houses were destroyed. As mentioned in earlier reports the only practical solution to the problem would be to conduct a full census of establishments with a view to obtaining full coverage.

I would like to take this opportunity to thank the management of the establishments that responded positively to the questionnaire. I earnestly appeal to the others to consider the national importance of surveys of this nature and give us their co-operation. My thanks are also due to the field staff as well as the clerical staff for their efforts in getting out this report. Finally I wish to express my appreciation to the officers of the Computer division of the Department of Census and Statistics for producing the final tables.

Mrs G.S.Ratnayake and Mrs L.Liyanage Statistical Officers were jointly responsible for the organisation and preparation of the final tables respectively. They worked under the guidance and direction of M/s A. Kahanda and J.K.G.J.Perera Statisticians.

INTRODUCTION

This is the twelfth report in the series on the Annual Employment Survey since its inception in 1971.

Briefly, the objectives of the survey are as follows:-

1. To collect data on employment annually, on a regular basis.
2. To work-out the indices of Employment and to compare the trends of employment every year.
3. To maintain a frame of Establishments to be used to select and conduct the Sample Surveys to obtain more detailed statistics.

For this type of survey there should be a minimum cut-off point of employment in deciding the establishments to be included. This is necessary because a systematic record of Addresses, number employed, nature of economic activity etc should be maintained yearly without change (births and deaths). Hence after careful study the cut-off point was decided to be 5 or more paid employees. At its inception in 1971 the frame was established by obtaining the list of business establishments from the F 1 forms of the Census of Population. This is the per listing form. From time to time steps were taken to revise and improve this frame. However all these efforts did not meet with a marked success. The survey of 1983 was greatly hampered because of the ethnic disturbances of July of that year and coverage was drastically reduced. Hence the data presented in this report should be treated cautiously as it does not represent a comprehensive picture.

Analysis of response is given in table 1.

Out of a total of 12678 establishments which were addressed 9892 were found to be eligible. Of this number only 6825 establishments responded with information while no data was forthcoming from the others. The rate of Non-response rose to 31% overall. Sector wise it is 35.8% for the public sector and 27.2% for the private sector. Communal disturbances which occurred in July 83 was the cause for this high rate of Non-response. Another reason could be the under coverage of establishments.

Ministry of Industries, Industrial Development board Employees Provident Fund registers etc. have been taken to improve the frame. However not much impact is to be seen by way of improvement. It must be mentioned that some establishments were reluctant to send back the completed forms even after follow up by reminders, and visits by the field staff.

In table II the number of establishments and the number of employed is decreasing progressively from year to year both for private and public sectors. This must not be taken to mean that the numbers of establishments and the numbers employed islandwide are decreasing. In reality, according to the prevailing situation in the country the employment could well be double what is shown here. Of the total employment 24.4 % is recorded for the private sector and 75.6 % for the public sector.

INDEX NUMBER OF EMPLOYMENT

When conducting this type of survey it is difficult to expect that the same establishment was reporting every year. There are births and deaths of establishments and much non-responding establishments from year to year. Hence common establishments reported for consecutive years (June '82 & '83) were compared to work out the Index numbers. The link-relative method was used. Further details of computation could be had by reference to reports of '79 & '80. Overall index for all industries increased by 3 % and the Index for June 83 was 125.7 as against 122.0 for the previous year. Indexes of Employment increased or remained the same in the Major Industries Agriculture Manufacturing, Trade, Transport, Business services, Community & personal services in 1983 as against 1982. The index decreased in the Mining & Quarrying industry as only a few establishments were covered in that industry.

Table 4 shows the changes in employment between 1982 & 1983. Taking common establishments which furnished returns for both years. The number of such establishments that submitted reports for both years was 5056 for both sectors combined. When compared with '81 & '82 there was a shortfall of 1540 establishments. The main factor could be the July disturbances resulting in the non submission of returns. However overall employment has increased by 2.59% over the year 1982 for both sectors in 1982 there was an increase of 3.69% in the public sector but in the private sector a decrease of 0.57%. The coverage of employment dropped in the manufacturing industry and was the main reason for the decrease noted above. Nevertheless these comparisons for consecutive years was very important as this was used to compute the Index numbers.

Table 5 & 6 gives the percentage distribution of employees for each sector, (Public, Private & Both combined) by Major industries and Major Occupational categories respectively. The percentage distribution of employees by Industry shows an almost similar pattern as compared to previous years. More weightage seems towards the major industry Agriculture 43 %, for the Manufacturing industry it was 21 % whilst for Trade it was 11 %. This has been the trend in the past and is likely to be so in the future as well since the economy is yet mainly dependant on Agriculture, followed by production and Trade. Table 5 further shows that the majority of employees in the Public sector was in the industry Agriculture whilst in the Private sector it was in the Industry 'Manufacturing' Employment distribution by Major Occupational category, the 'Unskilled' group bore a large proportion namely 53 %. The 'skilled' and 'Clerical' categories were next with 23 % and 11 % respectively. Furthermore it depicts that in the public sector the Unskilled category was 60 % whereas in the private sector the Highest was in the Skilled category being 40 %. According to both tables, the majority of the employees were concentrated under Agriculture and out of this most were in the Unskilled Category.
