P R E F A C E

The annual employment survey of the Department of Labour was designed to measure the levels and trends of employment in the organized sector in Sri Lanka on a continuous basis and it is conducted annually commencing from the year 1971. The present report "EMPLOYMENT SURVEY - 1991" is the seventeenth report in the series since then. The survey covers establishments having five or more paid employees and engaged in productive, distributive business and commercial activities in both private and public sectors. Coverage of the survey is not comprehensive due to not availability of complete lists of business establishments for the whole country.

The survey is conducted by using mail questionnaire technique taking last working day of month of June of corresponding year as the reference period. Under-coverage and high non response rate are the main factors influencing total figures, but other important characteristics such as changing employment pattern in the economy, distribution of employment among different industries or sex distribution by occupation in the organized sector are some of the very important findings of the survey.

Planning and the execution of the survey work was carried out by Mrs. D.L. Liyanage, Statistical Officer who was attached to the Division and preparation of final statistical tables and other related work done by Mr. H.D.R.G. Peiris, Statistical Officer with his staff of the Employment Survey unit of the Labour Statistics Division of this Department under the direction and guidance of Mr. A. Kahanda, Labour Statistician. Mr. Kahanda was also responsible for preparation of this final report.

The staff of the Data Processing Division of the Department of Census and Statistics was responsible for the processing work.

Finally, I wish to express my appreciation to all employers who responded to this survey and for their co-operation for the successful completion of the survey.

This is the seventeenth in the series of the Annual Employment Survey conducted by the Statistics Division of the Department of Labour. The first survey of this series was conducted in 1971 with the objective of collecting information on employment by industry and occupation from all the establishments in the country with five or more paid employees in the Private Sector and the manufacturing and service institutions coming under Public Sector. This survey has been conducted every year since 1971 by post (except 1987). The reference period for the survey continued to be the last working day in the month of June of the reference year. In 1971 complete list of establishments was obtained from the 1971 census of population and housing listing form (Form-F1). But since then such a complete list of establishments was not collected in one count and therefore the survey frame was not updated properly. Therefore total number of establishments in the survey frame was declined during the past few years. Due to this reason total number employed in both private as well as public sectors shows declining trend.

OBJECTIVE

The main objective of the survey was to collect statistical data on employment in organized sector by industry and occupations with a view to build up an index of employment and to watch employment trends of the economy.

ANALYSIS OF SURVEY RESULTS

The total number of establishment addressed in 1991 was 7,384 and the figure for 1990 was 9,969 and it shows 25.9 percent declined in number addressed. In 1990 out of total 9,969 establishment addressed (1990 Survey Report) 2,751 were outside the scope of the survey. i.e. establishment closed, duplicate or nil or less than 5 employees. Since those establishment names were deleted from the survey frame number addressed in 1991 were declined to 7,384.

As shown in Table I below in 1991 there were only 1,214 establishments outside the scope of the survey, of that 285 were closed or duplicate and 925 were nil or less than 5 employees. As shown in the table, number of eligible establishments were 6,170 of that 4,678 establishments submitted their forms. This shows responding rate was 75.8 percent, corresponding figure for 1990 was 70.9.

During the year under review number of establishments addressed and responded has declined with compared to previous years, but number of employees covered has increased. This employment coverage was remarkable high since 1984. Total employees covered in 1991 was 799,350 and it shows 4.8 percent increased over 1990. As shown in Table No II below, total employees covered in private sector was 261,342 and in public sector it was 538,008. This shows employment coverage in public sector has increased by 13.2 percent. Also number of reporting establishment in public sector has increased from 1,857 in 1990 to 2,040 in 1991 by 9.9 percent. As shown in Table II employment share in private sector has declined from 37.7 percent in 1990 to 32.7 percent in 1991. Employment coverage for private sector in 1990 was 287,624 and this was declined to 261,342 in 1991 by 9.1 percent.

These index numbers were calculated by dividing the current year employment by the corresponding figure for the previous year for each major industry division and then linking up by multiplying by the previous year index. This method has been adopted over the year since 1971 upto the present index for 1991.

Table III below, shows the index numbers of employment by major industry division, sectors and whole country for the period of 1988 to 1991.

INDEX NUMBER OF EMPLOYMENT

Index numbers are computed to monitor the trend in any field. It is accepted that the index numbers are the best indicator to monitor the trend. To monitor change of employment from year to year in the economy index numbers of employment has been used. Total employment obtain from the survey findings are not suitable to compute the index number of employment due to change of response from year to year. Therefore it is very difficult to maintain fixed list of establishments which response continuously. To overcome this situation it was decided to use the employment in common establishment between two adjacent year and compute the index. Normally better organized establishment with larger employment continued to responded regularly over the year. Therefore for the computation of the index number of employment, the establishments which responded over two adjoining years were matched each year. Taking 1971 as base year link relative method has been adopted in computation an index of employment for each major industry division.

As shown in the table over all index numbers for both sectors combined has increased from 117.8 in 1990 to 120.1 in 1991 by 1.95 percent. Index for public sector has increased by 8.6 percent from 121.3 in 1990 to 131.7 in 1991. Private sector index shown declining trend in 1991, index has declined from 155.3 in 1990 to 145.1 in 1991. Detail analysis of industry wise breakdown of the index number show 32.0 percent increase for both sector in transport, storage and communication division and private sector increase was more significant. It was gone up from 97.5 percent in 1990 to 148.2 to in 1991 by 52.0 percent. Public sector index for this particular group has increased by 29.0 percent from 126.4 in 1990 to 163.0 in 1991. Employment index for construction industry also gone up by 15.6 percent for both sectors during this period. It has increased by 41.9 percent in private sector from 75.2 in 1990 to 106.7 in 1991. Where as public sector increase was 9.8 percent during this period. Apart from above mention two industry, increase of employment index are shown in other industries such as Agriculture, Electricity, Gas and Water, Wholesale and Retail Trade and Restaurants & Hotels and the Financial Insurance, Real Estate and Business services.

Taking into consideration of the establishments which furnished information for both years 1990 and 1991, more detail industry wise analysis were made to study the employment trend in the economy. Table No IV below, illustrate more detail analysis of the employment trend year 1990 to 1991.

Percentage distribution of employees by sex and sectors are given in Table VII. As shown in table, female participation in private sector has increased significantly from 40.0 percent in 1989 to 56.5 percent in 1991. Proportion female in organized sector employment (total) also increased during this period from 37.6 percent in 1989 to 43.0 percent in 1991. Female employment in public sector has not change much during this period.

Number and percentage distribution of women employees to total employees (men and women) by major industry division, and major division of occupations are given in Table No VIII, IX and X. Female employment in organized sector are increasing gradually. As shown in Table VIII, proportion female employees in organized sector has increased from 41.8 in 1988 to 43.8 percent in 1991. This increasing trend is remarkably high in Manufacturing Sector. Proportion female in Manufacturing Sector has increased from 49.2 percent in 1988 to 57.6 percent in 1991. Major industry division such as Construction, Financing, Insurance, Real Estate and business services and community social and personal services also shows this increasing trend during this period.

Occupational distribution of female employees are given in Table IX. It shows number as well as percentage of female employees in occupational categories such as Sales Workers, Foreman and Supervisors, skilled and semi-skilled are increasing gradually.
